## **Proof of Citizenship Requirement: PASSPORT**

### **Deposit/Final Payment Policy:**

- \$425.00 per person due at time of booking to secure a cabin.
- Final Payment is due May 16, 2022

### **Cancellation Penalties:**

- If cancellation occurs from booking date to 5/7/22, a \$25.00 per person penalty will be assessed.
- If cancellation occurs between 5/8/22 and 6/21/22, a \$930.00 per person penalty will be assessed.
- If cancellation occurs between 6/22/22 and 8/16/22, the passenger is in full penalty and no refund will be granted.
- In addition to the cancellation policies listed above, if additional payments have been made to Starr for the purpose of securing your airline reservation, these monies are non-refundable once received.
- Any name changes after final payment is made will be assessed a per person change fee. The amount of the fee will be determined by the airline/cruise line.

### **Air Policy:**

- Air prices are estimated until airfare is confirmed.
