\*NCL's COVID REQUIREMENTS FOR THIS CRUISE AS OF 11/18/2022:

VACCINATED; Proof of up-to-date vaccination and/or booster regimen\*, at embarkation. NOTE: Guests who are unable to provide proof of up-to-date vaccination regimen\* at embarkation will be considered unvaccinated.

\*All guests age 18 and over, whose primary COVID-19 vaccination will be beyond 270 days at the time of disembarkation from their voyage, must have a COVID-19 booster prior to embarkation to be considered up-to-date. In lieu of a booster 270 days after the primary series, guests may present a government recognized or official medical Certificate of Recovery (dated no less than 10 days and no more than 180 days before embarkation). For all others unable to present a doctor's note, a laboratory confirmed PCR test result with the proper information (i.e. name, date, date of birth, positive result, etc.) will be accepted.

UNVACCINATED; Unvaccinated guests may be required to test occasionally throughout the voyage if deemed necessary by Greek Authorities. Guests would be responsible for the cost. *Approximate cost per COVID-19 antigen test is \$95. The approximate cost per PCR is \$199. These costs may vary and are the responsibility of the guest.*

**Cancellation Penalties:**

- If cancellation occurs from booking date to 4/14/23 a \$25.00 per person penalty will be assessed.
- If cancellation occurs between 4/15/23 - 6/14/23, a \$1,350.00 per person penalty will be assessed.
- If cancellation occurs between 6/15/23 - 9/2/23, passenger is in full penalty & no refund will be granted.
- Any name changes after final payment is made will be assessed a per person change fee. The amount of the fee will be determined by the airline/cruise line.
